Introduction and objective of this paper

- 1 The objective of this paper is to obtain Board approval of the draft project plan for the field test of the requirements of ED 261 *Service Concession Arrangements: Grantor*¹.
- 2 This paper is structured as follows:

 - (c) Field test description and objective (paragraphs 5-10).

Summary of staff recommendations

3 Staff recommend the Board approve the draft project plan for the field test of the requirements of ED 261.

Background

4 At the September 2015, the Board approved the project plan² for progressing the project on service concession arrangements from a grantor's perspective. A component of the project plan was to undertake a field test of the requirements of ED 261.

Field test description and objective

- 5 The draft project plan in paragraph 9 below details the proposed steps and timing for undertaking a field test of the proposals in ED 261.
- 6 The objective of the field test is to gain a deeper understanding of the issues in accounting for service concession arrangements to assist the Board in finalising the service concession arrangements project.
- 7 Staff expect that the field test may result in the inclusion of additional guidance and complex examples to address areas of concerns that constituents expressed during the comment period.
- 8 The field test comprises of the following key steps:
 - (a) Step 1: establish the composition of the participants to be involved in the field test and the terms of reference for the project;
 - (b) Step 2: field test participants apply the proposals in ED 261 to their specific service concession arrangement fact patterns. The participants will be requested to provide the AASB with the relevant service concession arrangement fact patterns and/or examples along with comments on the:
 - (i) likely accounting treatment for the specific fact patterns/examples;
 - (ii) issues experienced in applying the proposals of ED 261; and
 - (iii) suggested guidance that can be incorporated in the final Standard that would be useful in the application of the final Standard;
 - (c) Step 3: staff use the information from Step 2 to develop guidance and blended examples for possible inclusion in the final Standard; and
 - (d) Step 4: present the findings and proposed guidance to the Board for consideration and decision for their inclusion in the final Standard.
