The Reporting Entity Concept is a superior differential system that appropriately reflects the costs and benefits of financial reporting in Australia, and any change to the Reporting Entity Concept would not be in the best interests of the Australian

Small to medium sized business (ie turnover of <\$20m A) has no reason to be appropriate for these rules - irrelevant to their day to day and annual reporting obligations.
